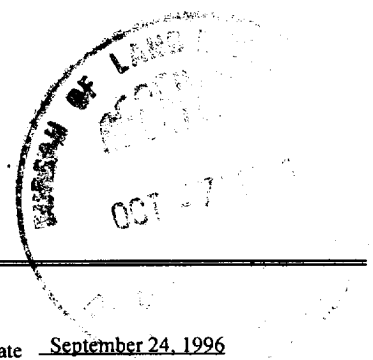
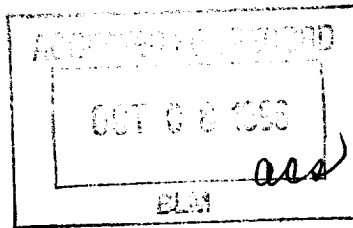

Spudded this well on 9/21/96 at 1330 hrs and drld a 12 1/4" hole to 1113'. On 9/22/96 ran 28 jts 8 5/8" 24# J-55 ST&C csg, set at 1112'. Cemented w/300 sxs lite "C" & 200 sxs "C". Circ'd 126 sxs cmt.

Drld 7 7/8" hole and reached TD 2400' on 9/25/96 at 0130 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 55 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2399'. Cemented w/150 sx lite "C" + 300 sx Class "C". Circ'd 89 sxs cmt.

Released rig at 1900 hrs 9/25/96. WOCU.
