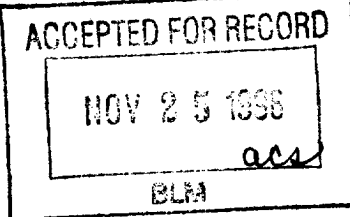

Spudded this well on 11/4/96 at 1300 hrs and drld a 12 1/4" hole to 1063'. On 11/5/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1062'. Cemented w/300 sxs lite "C" & 200 sxs "C". Circ'd 118 sxs cmt.

Drld 7 7/8" hole and reached TD 2500' on 11/8/96 at 0600 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 60 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2499'. Cemented w/150 sx lite "C" + 350 sx Class "C". Circ'd 29 sxs cmt.

Released rig at 2030 hrs 11/8/96. WOCU.
