

Spudded this well on 11/25/96 at 1700 hrs and drld a 12 1/4" hole to 1166'. On 11/27/96 ran 29 jts 8 5/8" 24# J-55 ST&C csg, set at 1165'. Cemented w/350 sxs lite "C" & 200 sxs "C". Circ'd 123 sxs cmt.

Drld 7 7/8" hole and reached TD 2550' on 11/30/96 at 1000 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 60 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2549'. Cemented w/200 sx lite "C" + 250 sx Class "C". Circ'd 30 sxs cmt.

Released rig at 0730 hrs 12/1/96. WOCU.
