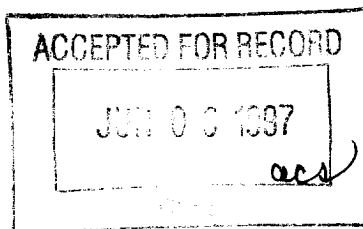

Spudded this well on 5/17/97 at 1300 hrs and drld a 12 1/4" hole to 1171'. On 5/19/97 ran 28 jts 8 5/8" 24# J-55 ST&C csg, set at 1170'. Cemented w/350 sxs lite "C" & 200 sxs "C". Circ'd 92 sxs cmt.

Drld 7 7/8" hole and reached TD 2600' on 5/22/97 at 2030 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 61 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2599'. Cemented w/200 sx lite "C" + 250 sx Class "C". Circ'd 43 sxs cmt.

Released rig at 1800 hrs 5/23/97. WOCU.
