

Spudded this well on 5/24/97 at 1200 hrs and drld a 12 1/4" hole to 1168'. On 5/27/97 ran 29 jts 8 5/8" 24# J-55 ST&C csg, set at 1167'. Cemented w/100 sxs lite "C" & 350 sxs lite "C". Circ'd 171 sxs cmt.

Drld 7 7/8" hole and reached TD 2650' on 5/29/97 at 1300 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 63 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2649'. Cemented w/250 sx lite "C" + 275 sx Class "C". Circ'd 105 sxs cmt.

Released rig at 1330 hrs 5/30/97. WOCU.
