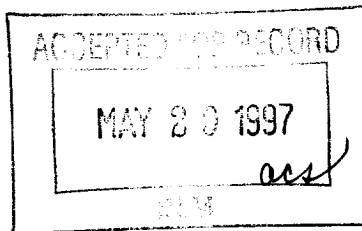

Spudded this well on 5/3/97 at 1400 hrs and drld a 12 1/4" hole to 1156'. On 5/6/97 ran 30 jts 8 5/8" 24# J-55 ST&C csg, set at 1156'. Cemented w/350 sxs lite "C" & 200 sxs "C". Circ'd 67 sxs cmt.

Drld 7 7/8" hole and reached TD 2650' on 5/9/97 at 0400 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 63 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2649'. Cemented w/225 sx lite "C" + 325 sx Class "C". Circ'd 86 sxs cmt.

Released rig at 0900 hrs 5/10/97. WOCU.
