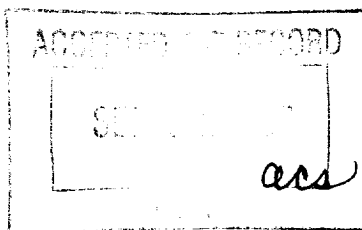

Spudded this well on 7/26/97 at 0730 hrs and drld a 12 1/4" hole to 1191'. On 5/27/97 ran 30 jts 8 5/8" 24# J-55 ST&C csg, set at 1190'. Cemented w/350 sxs lite "C" & 200 sxs lite "C". Circ'd 51 sxs cmt.

Drld 7 7/8" hole and reached TD 2650' on 8/9/97 at 0200 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 60 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2649'. Cemented w/250 sx lite "C" + 275 sx Class "C". Circ'd 95 sxs cmt.

Released rig at 1430 hrs 8/10/97. WOCU.
