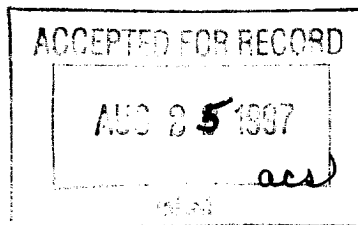

Spudded this well on 7/24/97 at 1330 hrs and drld a 12 1/4" hole to 1187'. On 7/26/97 ran 30 jts 8 5/8" 24# J-55 ST&C csg, set at 1186'. Cemented w/350 sxs lite "C" & 200 sxs "C". Circ'd 74 sxs cmt.

Drld 7 7/8" hole and reached TD 2750' on 7/29/97 at 2030 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 60 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2749'. Cemented w/250 sx lite "C" + 250 sx Class "C". Circ'd 76 sxs cmt.

Released rig at 1900 hrs 7/30/97. WOCU.
