Devon Energy plans to TA the San Andres perms @ 1663'-2519' by squeezing w/ cement. The well will then be deepened to $\pm 4300'$ to the Yeso Formation. After logging, a 4" liner will be run and cemented from 2650'-4300'. Plans are to perforate, stimulate, and pump test the Yeso. After approval of our downhole commingling application, the San Andres perforations will be re-opened by acidizing and the Yeso and San Andres zones will be downhole commingled.

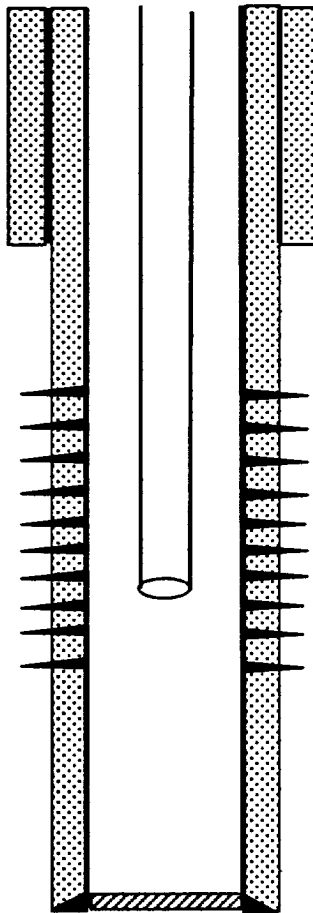

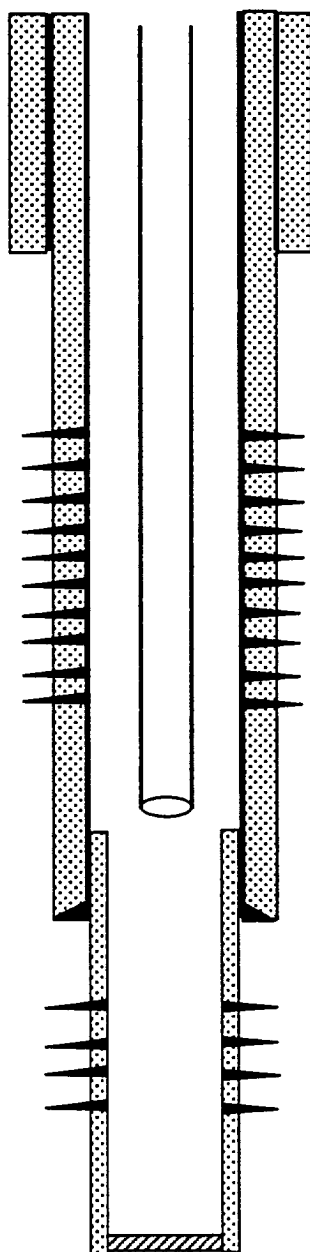
