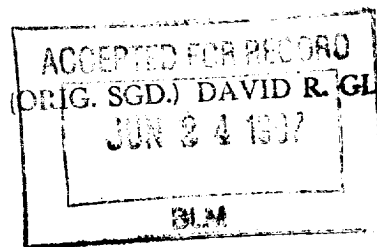

Spudded this well on 5/31/97 at 1000 hrs and drld a 12 1/4" hole to 1175'. On 6/4/97 ran 29 jts 8 5/8" 24# J-55 ST&C csg, set at 1174'. Cemented w/400 sxs lite "C" & 200 sxs "C". Circ'd 30 sxs cmt.

Drld 7 7/8" hole and reached TD 2700' on 6/14/97 at 1900 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 64 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2699'. Cemented w/225 sx lite "C" + 425 sx Class "C". Circ'd 150 sxs cmt.

Released rig at 2250 hrs 6/15/97. WOCU.
