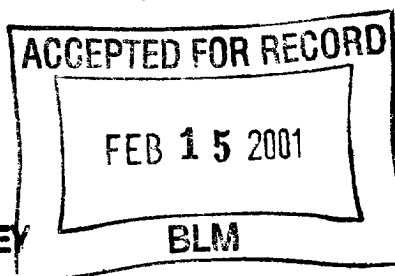

Spud 12-1/4" hole to 1175' on 10/18/00. Run 29 jts 8-5/8", 24#, J-55 csg. Set @ 1154'. Cmt w/375 sx Lite + 200 sx CI C. Circ 129 sx. WOC 18-1/4 hrs.

Drill 7-7/8" hole to 3450' TD. Reached TD 10/25/00. Cut 25 cores: 2313' - 3376'. Run 83 jts 5-1/2", 14#, K-55 csg. Set @ 3448'. Cmt w/250 sx 35/65 + 350 sx CI C. Circ 66 sx.
