Drld 7 7/8" hole and reached TD 2450' on 1/4/98 at 1600 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 58 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2449'. Cemented w/200 sx lite "C" + 300 sx Class "C". Circ'd 72 sxs cmt.

Released rig at 1400 hrs 1/5/98. WOCU.
