

Spudded this well on 12/14/97 at 1630 hrs and drld a 12 1/4" hole to 1078'. On 12/16/97 ran 25 jts 8 5/8" 24# J-55 ST&C csg, set at 1077'. Cemented w/100 sxs "C", 300 sx lite "C", tailed w/200 sx Class "C". Circ'd 86 sxs cmt.

Drld 7 7/8" hole and reached TD 2450' on 12/19/97 at 1730 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2449'. Cemented w/225 sx lite "C" + 325 sx Class "C". Circ'd 47 sxs cmt.

Released rig at 0900 hrs 12/20/97. WOCU.
