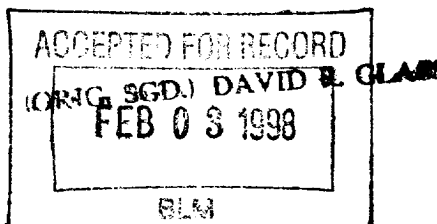

Spudded this well on 1/14/98 at 0930 hrs and drld a 12 1/4" hole to 1069'. On 1/16/98 ran 24 jts 8 5/8" 24# J-55 ST&C csg, set at 1068'. Cemented w/300 sx lite "C" and 200 sx Class "C". Circ'd 88 sxs cmt.

Drld 7 7/8" hole and reached TD 2450' on 1/19/98 at 0800 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2449'. Cemented w/175 sx lite "C" + 275 sx Class "C". Circ'd 63 sxs cmt.

Released rig at 0200 hrs 1/20/98. WOCU.
