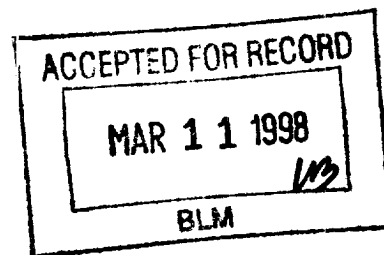

Spudded this well on 2/18/98 at 1830 hrs and drld a 12 1/4" hole to 1071'. On 2/20/98 ran 25 jts 8 5/8" 24# J-55 ST&C csg, set at 1070'. Cemented w/300 sx lite "C" + 200 sx Class "C". 74 sxs of cmt returned to surface.

Drld 7 7/8" hole and reached TD 2450' on 2/23/98 at 1800 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 58 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2449'. Cemented w/200 sx lite "C" + 275 sx Class "C". Circ'd 51 sxs cmt.

Released rig at 1800 hrs 2/24/98. WOCU.
