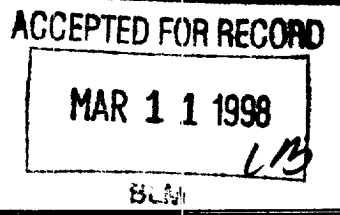

Spudded this well on 2/11/98 at 1630 hrs and drld a 12 1/4" hole to 1086'. On 2/14/98 ran 25 jts 8 5/8" 24# J-55 ST&C csg, set at 1085'. Cemented w/300 sx lite "C" + 300 sx Class "C". 138 sxs of cmt returned to surface.

Drld 7 7/8" hole and reached TD 2450' on 2/17/98 at 0700 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2449'. Cemented w/200 sx lite "C" + 300 sx Class "C". Circ'd 60 sxs cmt.

Released rig at 0930 hrs 2/18/98. WOCU.
