Spud well on 10/30/98 at 2000 hrs and drld a 17 1/2" hole to 185'. On 10/31/98 ran 4 jts 13 3/8" 48# H-40 8RD ST&C csg, set @ 183'. Cemented w/ 300 sx class "C", cmt did not circulate. TIH w/ 1" pipe to 76' and cmt w/ 150 sx class "C". 20 sx cmt returned to surface. WOC 12 hrs.

Drld 12 1/4" hole to 1023'. On 11/2/98 ran 23 jts 8 5/8" 24# J-55 8RD ST&C csg, set @ 1018'. Cemented w/ 400 sx 35:65:6 "C" + 250 sx class "C". 95 sx cmt returned to surface. WOC 18 hrs.

Drld 7 7/8" hole and reached TD 2354' on 11/5/98 at 2400 hrs. Schlumberger ran LDT/CNL/DLL/MSFG/GR logs. Ran 55 jts 5 1/2" 15.5# J-55 8RD LT&C csg, set @ 2350'. Cemented w/ 350 sx "C". 30 sx cmt returned to surface.

Rig Released at 2030 hrs 11/6/98. WOCU.
