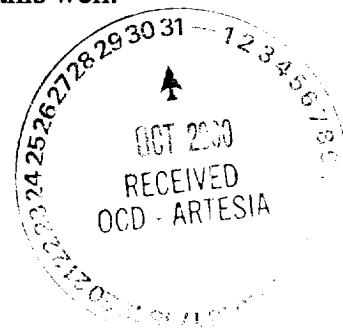
The Application for Permit to Drill this well was approved February 12, 1998.
