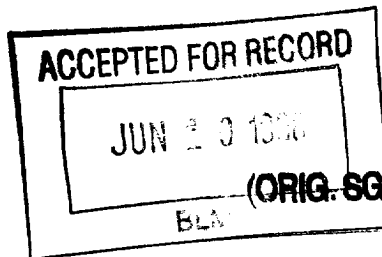

Spud well on 5/14/98 at 0830 hrs and drld a 12-1/4" hole to 1160'. On 5/16/98 ran 26 jts 24# J-55 8RD ST&C csg, set at 1095'; cemented w/ 350 sx lite "C" + 200 sx Class "C". 6 sx cmt returned to surface.

Drld 7-7/8" hole and reached TD 2450' on 5/19/98 at 2400 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5-1/2" 15.5# J-55 8RD LT&C csg, set at 2449'. Cemented w/ 200 sx lite "C" + 225 sx Class "C". 30 sx cmt returned to surface.

Released rig at 0730 hrs 5/20/98. WOCU.
