Drld 12 1/4" hole to 950'. On 4/4/98 **ran 22 jts 8 5/8" 24# J-55 8RD ST&C csg, set @ 941'**. Cemented w/ 350 sx lite "C" + 250 sx class "C". 60 sx cmt returned to surface.

Drld 7 7/8" hole and **reached TD 2255' on 4/6/98 at 0230 hrs**. Schlumberger ran LDT/CNL/DLL/MSFG/GR logs. **Ran 51 jts 5 1/2" 15.5# J-55 8RD csg, set @ 2247'**. Cemented w/ 400 sx class "H". 60 sx cmt returned to surface.
