Drld 12 1/4" hole to 988'. On 5/1/98 ran 24 jts 8 5/8" 24# J-55 8RD ST&C csg, set @ 987'. Cemented w/ 350 sx lite "C" + 250 sx class "C". 75 sx cmt returned to surface. WOC 18 hrs.

Drld 7 7/8" hole and reached TD 2690' on 5/5/98 at 0800 hrs. Schlumberger ran LDT/CNL/DLL/MSFG/GR logs. Ran 62 jts 5 1/2" 15.5# J-55 8RD LT&C csg, set @ 2689'. Cemented w/ 510 sx class "H". 114 sx cmt returned to surface.
