Drld 12 1/4" hole to 1019'. On 4/11/98 ran 23 jts 8 5/8" 24# J-55 8RD ST&C csg, set @ 1010'. Cemented w/ 350 sx lite "C" + 250 sx class "C". 85 sx cmt returned to surface.

Drld 7 7/8" hole and reached TD 2300' on 4/14/98. Schlumberger ran LDT/CNL/DLL/MSFG/GR logs. Ran 53 jts 5 1/2" 15.5# J-55 8RD LT&C csg, set @ 2299'. Cemented w/ 400 sx class "H". 84 sx cmt returned to surface.
