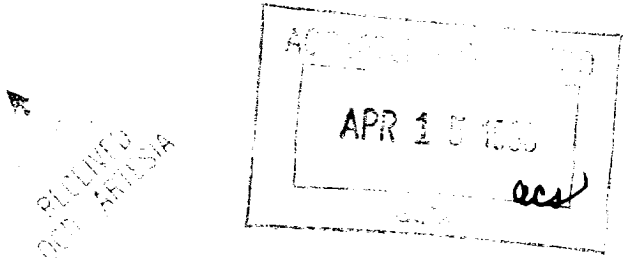

Drilled to 354'. C&C hole. RU and run 9 jts 13-3/8", 48#, H40, STC casing. Set casing to 354'. Cement casing using 420 sx cement plus additives. Circulate 120 sx cmt to surface. WOC for 12 hrs. Cut off casing and weld on wellhead and test. NU BOPE.
