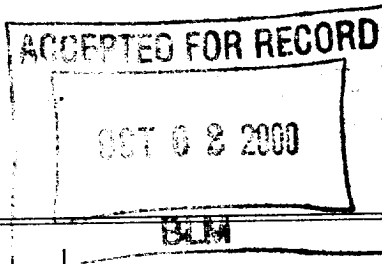

Tailed in with 250 sacks Super H, .5% Halad 344, .2% HR7, .4% CFR3, 5#/sack gilsonite and 1#/sack salt (yield 1.70, weight 13.0). PD 5:00 PM 6-1-2000. Bumped plug to 3100 psi for 3 minutes, OK. Circulated 21 sacks. WOC. Released rig at 10:00 PM 6-1-2000. NOTE: Displaced with fresh water. Notified Gene Hunt w/BLM-Carlsbad of casing and cement.
