Cemented with 3 sx GW-27, 200 sx Class "H" with additives, 600 sx 35:65:6 "C" with additives. Tailed in with 200 sx Class "C" with additives. PD 7:50 AM 7/20/02. Did not circulate. WOC 6 hrs., ran temperature survey TOC at 400'. Ran 1" in hole. Tagged up at 404'. Notified Phil Hawkins OCD of operations 5:30 PM 7/20/02. Reduced hole to 7-7/8" and resumed drilling.
