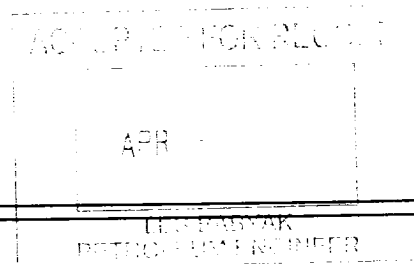

Cemented with 1310 sxs 35:65:6 C + 1% CaCl<sub>2</sub> + 5# LCM-1 + 1/4 pps celloflake (yld 1.96, wt 12.5). Tailed in with 200 sxs C + 1% CaCl<sub>2</sub> (yld 1.34, wt 14.8). PD at 11:30 PM. Bumped plug to 1400 psi, held OK. Circ 158 sxs. WOC.

Notified Durcan with Hobbs BLM of intent to cement.

12/18/01 - Drilled out at 3:45 AM. WOC 28 hours 15 mins.

Reduced hole to 7-7/8" and resumed drilling.
