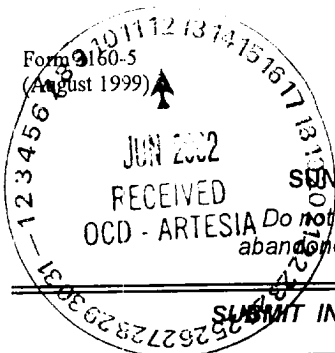

Cement casing with 150 sx Premium Plus with 3% Econolite, 2% Calcium Chloride and 1/4# Flocele Lead and 150 sx Premium Plus with 2% Calcium Chloride. Did not Circulate.

Ran 1" and tag @ 140'.

Cement with 75 sx Premium Plus with 3# Calcium Chloride.

Ran 1" and tag @ 110'.

Cement with 75 sx Premium Plus with 2% Calcium Chloride. Circ 10 sx to pit.

Cut off 11 3/4 casing and weld on 13 5/8 3000# X 11 3/4 SOW.
