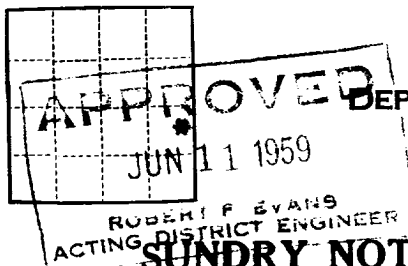

## DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

In accordance with Form 9-331a, approved 2-20-59, the above well was recompleted as follows: Drill plug to 9631, on 3-9-59, 4-1/2" casing was set at 9631' and cemented with 125 sacks 2% gel also set plus 125 sacks Pommix "S", top cement by temperature survey 8965'. Tagged bottom at 9537' and tested casing with 3800 psi for 30 minutes, no drop in pressure. Perforated 9442-9475 w/2 shots per ft., and acidized with 3000 acid, fracked with 30,000 gallons brine water and 18,000 pounds of 20/40 sand. On test well produced no oil and small quantity of gas. Perforated 9442-46, 9454-58 w/6 shots per ft., and vibro perforated 9442-46, 9454-9458 w/2 shots per some and vibro fracked perforations with 2 number 4 charges, and water fracked with 40,000 gallons brine water containing 10,000 sand. On test flowed at stabilized rate 357 MEFPD during 16 hrs., on 14/64" choke, TFF - 300, CPF - 410.

The well is presently shut in pending pipe line connection.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
