FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

We propose to plug and abandon this well at a total depth of 2753 feet, in the following manner:

Bail hole dry to the total depth, fill with Aquagel to 2730 feet, bridge and plug with 5 sacks of cement, Aquagel to 2300 feet, bridge and plug with 5 sacks of cement, Aquagel to 1050 feet, bridge and plug with 5 sacks of cement, Aquagel to 300 feet, bridge and plug surface string with 5 sacks of cement, knock off pipe, pull surface string, mud to surface and set marker in cement.
