Plugged back from 2215 to 2200 with rock. Dumped 10 sacks of cement. Filled hole with mud back to 1775. Put in bridge and damped 5 sacks of cement. Filled hole with mud to 1530. Bridged and dumped 5 sacks of cement. Filled Hole with mud to 385 and put bridge in casing back to 350. Put in 10 sacks of cement. Filled hole with mud to top. Filled Cellar with rock on cement with 4" pipe for marker.
