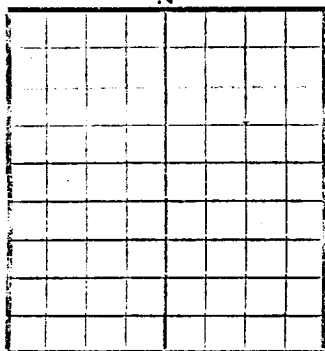

FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

I would like to set tubing and packer in the above described well at a depth of approximately 1000' and use said well for an input well and water disposal well. This well is approximately 75 feet lower on structure than the Harvey E. Yates, Snowden & Mc Sweeney # 1 which is a producer. It also makes a hole full of sulphur water at the same horizon as the Harvey E. Yates Snowden & Mc Sweeney # 1 is producing from. The Snowden & Mc Sweeney well produces a large percentage of sulphur water while making its oil and necessarily the disposal of the water is a problem. If, however the Harvey E. Yates State # 1 could be used for a disposal well the disposal problem would be solved and also the reservoir pressure might be more nearly maintained.
