DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

2920' to 2800 gravel-150# lead wool from 2800' to 2795-Pumped five sacks cement onlead from 2795 to 2785. Mud back to 1885 andbridge at 1885 gravel back to 1849-100# leadwodl, ten sacks cement on lead. 1835' of 7" OD pipe cemented in hole, knocked off and recovered 1550'. Tubing run in holeto the top of the bridge. 500 sacks cement was pumped into the hole with 3 c/c calcium chloride. This brought the cement solid up thru the salt section into the 8" surface pipe. 405' of 8" pipe cemented in hole, knocked off and recovered 100', Cemented with fifty sacks-Tubing run back in hole and 100 more sacks cement pumped in on top other cement. Cement bridge placed at top of hole and regulation macker set-March 17, 1953.
