13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. OSO #4 Section III. C. 1. a. requires that each sales tank shall be equipped with a pressure vacuum thief hatch and vent line valve. The purpose of the requirement is to prevent loss of product at low volume and pressure or by flashing of light ends in high gravity oil.

A fluid with an API gravity below 36 degrees will not have a significant flashing of light ends within the normal temperature range. The loss of gas from a low volume facility would be insignificant if the sales tank is vented to the atmosphere.

OSO #4 provides for granting requests for a variance from the minimum standards. Oil produced from this lease has a gravity of 32.0 and the lease produces 3 barrels of oil per day.
