PURPOSE: ALLOWABLE REVISION


Dear Sir:

Recently oil production was increased on the William A. and Edward R. Hudson Shugart "A" lease in Section 10-18-31, Eddy County, New Mexico. These increases were due to installing a pumping unit on well #2 and dissolving salt in wells #3 and #4 with a fresh water injection. These wells will now produce as follows:

Shugart A #1N- 2	BOPD
2K-10	"
3G- 4	"
4H- 4	"
5U-12	"

It would be appreciated if you would change the allowables accordingly as soon as possible, in order to prevent shutting the wells in.
