We propose to cement behind 7" casing (if necessary). Perforate the Yates at 2602' to 2606' w/2 JSPF and acidize and fracture. These perfs will then be tested to determine Yates productivity in the area. A cement bond log will be run to determine the top and the condition of cement behind the 7" casing. If no cement is present, the casing will be cemented through 4 holes at 2650' w/50 sax of Incor cement.

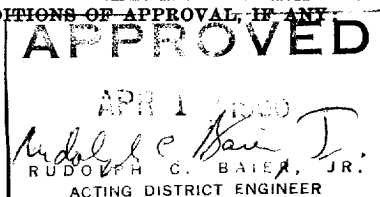

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
