Injection rates on this well have averaged 2 BWPD for the past 4 to 5 months. Injection pressure averages 1450 psi. It is not economical to continue injection at this time. We propose to temporarily abandon this well pending further study of the waterflood project. Tubing and packer will be removed and well capped with a swage and 2000# WOG master valve.
