INTERVIEW OF JAMES EARL RAY, CONDUCTED BY NEW YORK OFFICE, APRIL 1, 1968.

RAY STATED THAT HE WAS BORN IN MOBILE, ALABAMA, ON JANUARY 5, 1928.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES ARMY FROM 1946 TO 1950.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES NAVY FROM 1950 TO 1954.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES AIR FORCE FROM 1954 TO 1958.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES MARINE CORPS FROM 1958 TO 1962.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES COAST GUARD FROM 1962 TO 1966.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES CUSTOMS AND BORDER PROTECTION FROM 1966 TO 1968.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES DEPARTMENT OF JUSTICE FROM 1968 TO 1972.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES DEPARTMENT OF AGRICULTURE FROM 1972 TO 1976.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES DEPARTMENT OF COMMERCE FROM 1976 TO 1980.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES DEPARTMENT OF EDUCATION FROM 1980 TO 1984.

HE STATED THAT HE WAS A MEMBER OF THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES FROM 1984 TO 1988.
