We will then drill to approximately 4250 feet and set 5 1/2" casing and cement with not less than 1200 sacks of cement. We will then perforate the Queen section and complete the well through perforations in the zone between 3,300 and 3,700 feet.

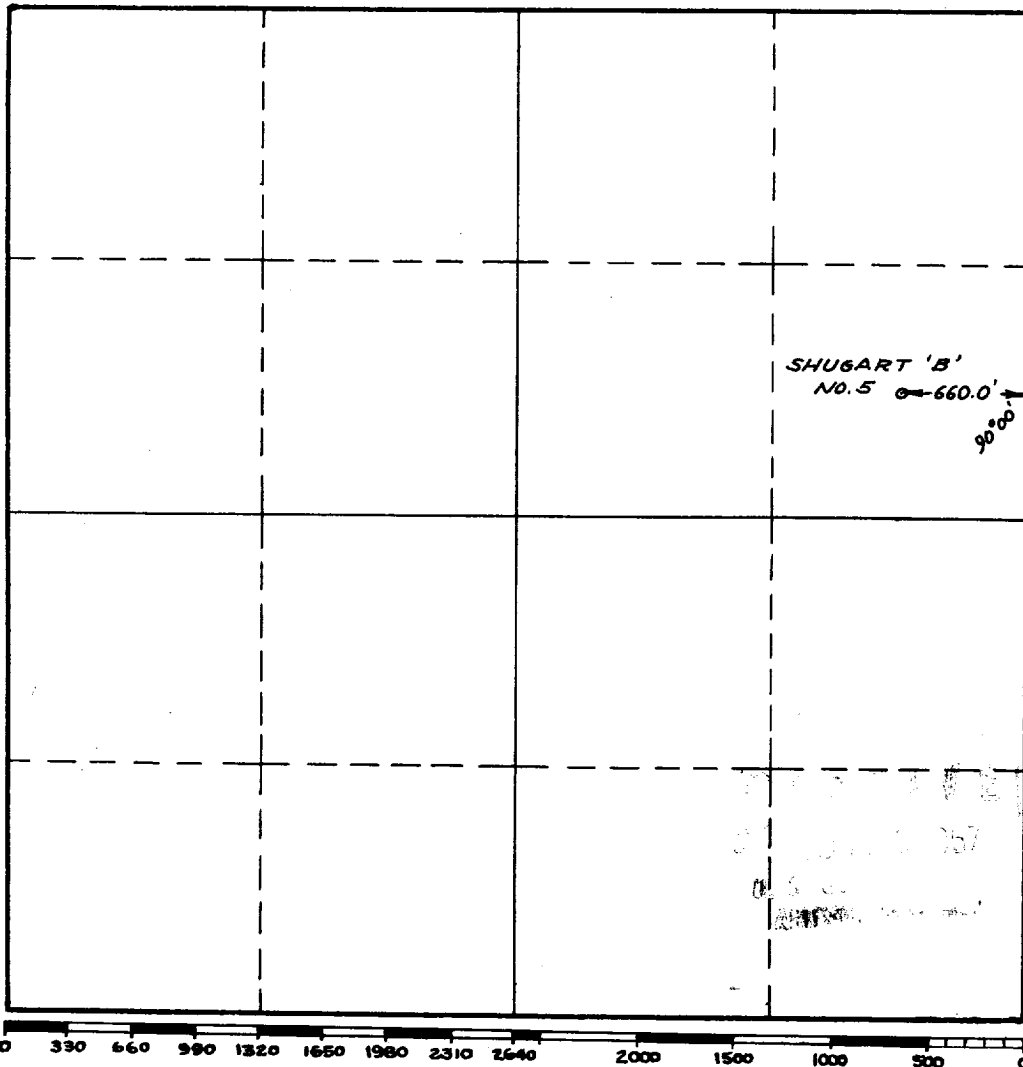
