This well is presently pumping 5 barrels of oil plus 3 barrels of water per day. We propose to dump 20 barrels of hot water down casing and pump this out to clean bore hole. 5½" 15.5# casing will be re-perforated at 3362-72 with 4 holes per foot. We will frac down 5½" casing with 15,000 gallons Redi-frac plus 20,000# sand. Frac will be preceded with a treatment of S#9 gyp preventative plus 150 gallons of regular acid.

Instructions
