On 3-14-94, the above captioned well was plugged and abandoned in the following manner:

Set a cement retainer at 1950'. Circulated well bore with 9# mud ladden fluid. Stung into retainer and pumped 75sx of Class "C" Neat Cement into formation. Pressure to 1000 PSI. Stung out of retainer and capped with 10 sx of Class "C" cement. RIH and perforated at 810' and shut down.

On 3-15-94, RIH with 2 7/8" tubing to 850'. Pumped 15sx of Class "C" cement outside the 5 1/2" casing and 60sx of Class "C" inside the 5 1/2" casing. Waited 4 hours and tagged cement at 567'. Pumped 28 more sacks of Class "C" cement to bring TOC to 300'. Perforated 5 1/2" - 8 5/8" casing at 50', established circulation and SD.

On 3-16-94, Pumped 50sx of Class "C" cement to fill 5 1/2", 8 5/8" casing to surface. Cut off well head, rigged down pulling unit, and install Dry Hole Marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
