

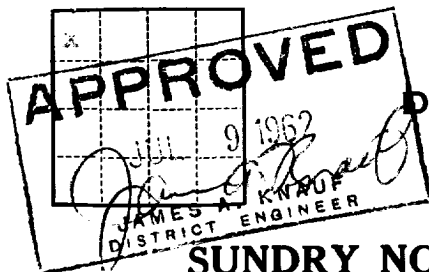

DETAILS OF WORK

We propose to drill a well at the above location to a depth of approximately 3000 feet to test the queen formation.

We will run approximately 800 feet of 8 5/8" casing and cement with 50 sacks.

We will run an oil string to total depth, cementing with 100 sacks and perforate into the producing zone.

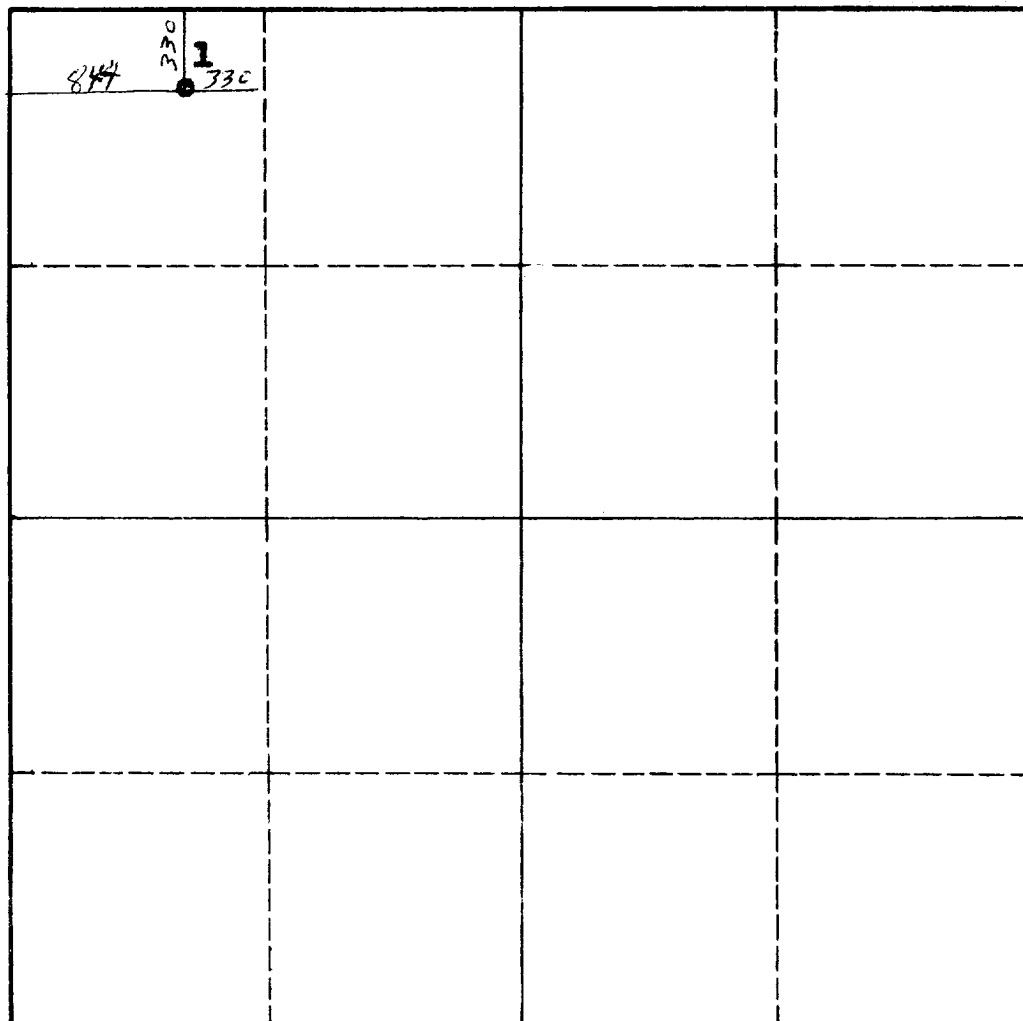
