Detailed account of work done, nature and quantity of materials used, and results obtained.

1. Drilled to TD 3350'. Ran Welox Induction Electric Log and Gamma-Ray Neutron Log from surface to TD. Dumped 2 sz cement plug on bottom and plugged hole back to 2900' with pea gravel.
2. Ran 2 7/8" buttress thread casing to 2855' and cemented w/250 sz 50-50 Incon Peamix 2% Gel. Used centralizers on 30' spacing TD up to 2520'. Temperature Survey showed cement @ 1900'. Plug down 6:00 P.M. 6/26/61.
3. WOC 24 hrs. Held 3000# pressure O.K.
4. Perforated 2609'-2636' and 2760'-85' 2 holes/ft.
5. Fractured zone w/15,000 gallons refined oil, spearheaded w/500 gallons acid and 40,000# sand.
6. Potentialled 360 BOPD, no water, GOR 1860.
