PLUGGING PROCEDURE

1. Set C.I.B.P. @ 2500' - Dump 35' cmt in 5 1/2" csg. on top of C.I.P.B.
2. Load hole with 9.5# mud.
3. Cut 5 1/2" csg @ 1925' - Set 100' plug over 5 1/2" csg stub.
4. Pull casing up to base 8 5/8" csg @ 905' -Set 100' cmt plug @ 905'.
5. Pull casing and set 10' cmt plug @ surface.
6. Set regulation well identification marker in top of surface casing.
