Pulled completion assembly and found that packer had failed. Ran retrievable BP and set at 2930'. Tested 4-1/2" casing above all perforations to 20000#. Held OK. Injected approximately 5800 barrels of water into Yates (Upper) perms w/no evidence of communication to surface. Ran tracer survey which showed all injected water to be contained in Yates formation. Apparent communication due to packer failure. Ran new packer on 2" tubing and set at 2919'. Resumed water injection down 2" tubing into Queen formation and down casing annulus to Yates. Work complete on 8/6/66.
