Per conversation w/ Alexis Swoboda on 11/24/97, plans are to P & A the well as follows: Set cmt retainer @ +3330'. Sqz cmt Queen perfs @ 3381'- 3925' w/ 100 sxs leaving 50' of cmt on top. Set 35 sx cmt plugs @ 2400' - 2200' & 1400' - 1200'. Tag plug @ 1200'. Set 10 sx surf plug from 50'- surf. Cut off wellhead & install dryhole marker.
