Moved in pulling unit. Cleaned out well with sand pump from 3446' to 3900'. Lane Wells ran cement bond log & GR-N log. Perforated 4 holes at 2869-70. Block squeezed bottom of Yates zone w/165 sx of cement in 3 stages. Max. & final squeeze pressure = 3500#. Perforated Yates with one 3/8" OD jet shot @ 2733, 2735, 2737, 2753, 2755, 2777, 2779, 2789, 2792, 2795, 2810, 2813, 2816, 2819 & 2822 (15 holes). Treated w/2000 gallons 15% HCl acid & ball sealers. Fraced down 2-1/2" tubing w/32,000 gallons of slick fresh water containing 32,000# of 20/40 sand. AIR=13.4 BPM @ 2950#. Job complete @ 5:05 PM 1/30/68. Swabbed well 3 days. Pulled ret. BP. Ran 2" tubing to 3417' & placed well on rod pump 2/4/68. On 24 hour test 2/15/68 well pumped 5 BO & 18 bbls load water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
