DETAILS OF WORK

On July 7, 1961 we recovered all of the 782' - 8 5/8" OD 3.H. Casing which had been run and mudded in the hole. Cement plugs were placed as follows:
35 sz - Approx. 100' at 800' - 900'
35 sz - Approx. 100' at 2100' - 2200'
35 sz - Approx. 100' at 2600' - 2700'
Marker has not been set as it will be in way in skidding substructure back while moving rig from present sight. Location not yet cleaned nor pits filled. These requirements will be reported when done.
