**DETAILS OF WORK**

We propose to test the Queen Sand by use of rotary tools. Our proposed casing program is as follows:  
Run 250' - 8 3/8" OD SH Casing and circulate cement  
Run 3400' - 4 1/2" OD New Casing and cement w/125 sx.  
After test is made and if well proves to be a commercial well, the 4 1/2" casing will be two-staged by use of 1" tubing.  
50 sx. cement will be pumped around 4 1/2" casing with bottom of tubing at approximate 840 feet. We hope to start drilling in day or so.

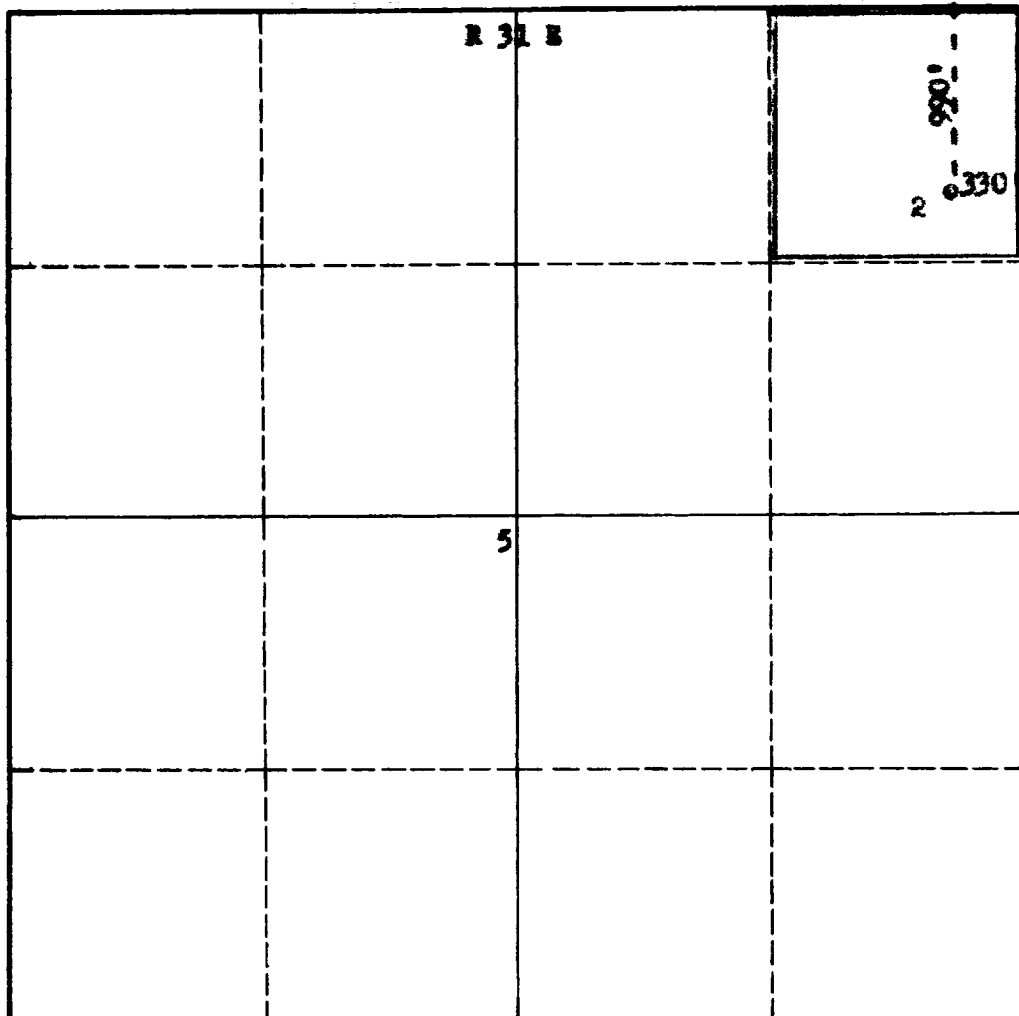
