DETAILS OF WORK

We propose to drill the Texas Crude Oil Company, 1-21 Tennessee-Federal as a 5000' test as follows:

Drill 17-1/4" hole in the Red Beds or the top of the Anhydrite at approx. 600' and cement 13-3/8", 48# casing. (Circulate cement to surface).

Drill 12-1/4" hole 100' below base of salt to approx. 2150' and cement 9-5/8" casing w/50 sacks cement.

In the event production is found, the salt production string will be re-cemented with sufficient cement to circulate.

Verbal approval received by telephone May 28, 1959, from USGS.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
