Reference is made to your Notice of Intention to Drill well Southern Federal No. 1 (copy attached), NE1/4 sec. 30, T. 19 S., R. 31 E., N.M.P.M., Eddy County, New Mexico, on lease New Mexico 06814. Inasmuch as the lease lies within the potash area designated by the order of the Secretary of the Interior dated October 16, 1951, the Director, U. S.
